

- 5. Applicable Club Chartering <u>Fees</u> in the form of a **check or money order**, **no cash**, made payable to "SBCDCC;"



 <u>Taxpayer Identification Number</u> (TIN/EIN): You must have a TIN/EIN number to be chartered. Banks require this number to open an account. TIN/EINs are provided by the IRS by filing Form SS-4. Apply on line at www.irs.gov or obtain Form SS-4 by calling 1-800 TAX FORM;

Federal Taxpayer ID Number (EIN)

7. <u>California FPPC ID Number (optional)</u>: If a club engages in California campaigning then you must file with the California Fair Political Practices Commission (FPPC).



8. <u>FEC ID Number (optional)</u>: If a club engages in federal campaigning (President, U.S. Senate, Congress) then you must file with the Federal Elections Commission (FEC).
